If selected, NHEC will provide a scholarship that will cover all major costs of the 7 day Institute. There is a post-Institute follow-up process with students. The Institute is open to all, and applicants from every race, gender, ethnicity, etc. are welcome to apply. See our “Fact Sheet” and “Application Information: How to Apply” for detailed information on the Institute. NHEC reserves the right to make changes to the Institute, including revisions to the curriculum. If selected, students will be notified and provided with further information on the Institute. The Institute is being funded by the National Park Service and NPS is actively participating in the Institute. NHEC will provide Institute sponsorships to qualified students only up to the limits of available funding.
